

## Statement of Consent to Personal Data Processing

I, the undersigned, acting as Author (Co-Author) of the Text, by submitting some of my personal data to the Editorial Board of the Journal "Nizhny Novgorod Linguistics University Bulletin" (hereafter "LUNN Bulletin"), shall accept and sign this Statement of Consent to Personal Data Processing (hereafter "Consent"). I shall assume as form of accepting the offer of consent my logging in at the Journal's website or providing the required personal data as part of log-in application (the form title subject to variation) procedure, as posted on the website.

I hereby give my consent for Nizhny Novgorod State Linguistics University named after N.A. Dobrolyubov, which is the owner of the website of the Journal "LUNN Bulletin" ([vestnik.lunn.ru](http://vestnik.lunn.ru)) and is located at: Minin St., 31-A, Nizhny Novgorod, Russia 603155, to process my personal data as follows:

1. This Consent implies personal data processing with or without computer technologies.

2. I give this Consent to personal data processing solely for the purpose of having my article(s) published in the Journal "LUNN Bulletin".

3. My personal data shall be processed under Article 6 of Federal Law No. 152-Φ3 "On Personal Data" and other applicable federal laws and regulations.

4. My personal data processing shall imply the following: collection, recording, systematizing, accumulation, storage, validation (updating, amending), retrieval, utilization, depersonalization, blocking, deletion, destruction, transfer, dissemination – all of the above solely for the purposes stated in paragraph 2 of this Consent. I hereby agree that, when published, my personal data will be publicly available and posted on this publicly available website in the Internet.

5. My personal data shall be transferred to any third parties under the laws of the Russian Federation, under an agreement I shall be a party to or with my consent.

6. My personal data shall be processed until all relevant procedures have been completed. The processing could also be terminated at my request. My personal data, recorded in hard copy, shall be stored subject to Federal Law No. 125-Φ3 "On Archive Keeping in the Russian Federation" and other rules and regulations pertinent to archiving and archival storage.

7. I may withdraw my consent in person or through my due representative by way of mailing a written statement to LUNN or its representative to the address first above written.

8. Should I wish to withdraw my consent in person or through my due representative, LUNN shall have the right to proceed with my personal data processing without my consent, should there be found any of the grounds set forth in paragraphs 2-11 of Part 1 of Article 6, Part 2 of Article 10 and Part 2 of Article 11 of Federal Law No. 152-Φ3 "On Personal Data", dated June 26, 2006.

9. This Consent shall be in effect up until termination of my personal data processing for reasons stated in paragraph 8 hereof.
